RE: WARN Act Notification - Boyd Coffee Company - Represented Employees

Dear Sirs/Madam:

As you know, due to the Asset Purchase Acquisition of Boyd's by Farmer Bros. and the subsequent transition of all customers and business to them, Boyd's will be discontinuing operations beginning May 23, 2018 with all separations accomplished by October 1, 2018. This discontinuation will result in multiple layoffs beginning with this first layoff.

The expected date of the beginning of the position eliminations and layoffs is: May 23, 2018. The layoff is permanent. There will be no recall.

The location of the facility affected is:

Boyd Coffee Company 4085 W. Eleventh Ave., Unit 2 Eugene, OR 97402

Pursuant to Article 8.5 of the labor agreement, the layoffs will be conducted on a seniority basis within each affected classification. Attached as Schedule A is a list of the bargaining unit employees who will be affected by the first layoff. The bargaining unit employees have bumping rights. There are approximately 72 bargaining unit employees.

The attached list, Schedule A, lists the names and positions of affected employees. These employees do have bumping rights based on seniority. The union that represents employees is Teamsters, Local 206. The Chief Elected Official is:

The anticipated schedule for subsequent separations is: May 23, 2018 – June 6th due to bumping rights. Schedule B lists the position titles of those less senior positions that might be affected.
