**RE: WARN Act Notification** 

Mr. Asher:

Due to the announcement by Washington Governor Jay Inslee on March 15, 2020, and Oregon Governor Kate Brown on March 16, 2020 that effective March 17, 2020 for at least two weeks in Washington, and four weeks in Oregon, restaurants and bars are ordered closed for dining in. This has affected the operations of Elmer's Restaurants, Inc., a non-union company.

Because of this notification, we have had to temporarily lay-off a total of 83 employees in Washington State, and 296 employees in Oregon at the following locations operated by Elmer's Restaurants, Inc. The return to work date is currently unknown, but best estimate is March 31st for Washington employees, and April 15, 2020 for Oregon employees.
