Re: Notice of Employment Termination Due to COVID-19 Pandemic Aramark at Nike (Lifeworks)

To Whom It May Concern:

Due to the impact of the unprecedented disruption to our business caused by the COVID-19 global pandemic, Aramark made the difficult decision to take action and implement temporary furloughs.

At the time we made the decision, we expected the furlough to be temporary in nature as we fully expected Nike to resume operations within a few months Unfortunately, the account intends to operate with reduced employee capacity indefinitely and does not anticipate a need for our full food and/or facility services for an undefined period of time.

Accordingly, this letter will serve as notice in accordance with the Federal Worker Adjustment and Retraining Notification Act, 29 U.S.C. § 2101 et seq. ("WARN") and any applicable state or local WARN laws.

We regret to inform you that many of the Aramark employees assigned to that client account will be or have been affected.





- 1. As a result of the reduction in force described above, Aramark expects to terminate many of the employees at Nike as of September 25, 2020. We anticipate opening additional outlets at this account as soon as reasonably feasible depending on the evolving COVID-19 pandemic and based upon our client's business needs but do not yet know when that will occur.
- 2. The specific job titles of our employees affected by this reduction in force, as well as the number of our employees in each job classification, are listed on the attachments to this notice.
- 3. There are no bumping rights applicable to these employees.
- 4. Our employees affected by this reduction in force are not represented by a union, but all affected employees have been notified of their termination from employment.
