RE: WARN Act Notification

Mr. Asher:

Due to the announcement by Governor Kate Brown on November 13, 2020 that effective November 18, 2020 for at least two weeks (and anticipating up to four weeks in certain counties) restaurants and bars are ordered closed for dining in. Washington Governor Jay Inslee also announced a four week freeze on November 15, 2020 that will take effect on November 18, 2020 and last until at least December 13, 2020. This has affected the operations of Elmer's Restaurants, Inc., a non-union company.

Because of this notification, we have had to temporarily lay-off a total of 280 employees in Oregon State and 94 employees in Washington State at the following locations operated by Elmer's Restaurants, Inc. The return to work date is currently unknown, but best estimate is between December 2nd and December 17, 2020 for Oregon and December 13, 2020 in Washington State..


