Attention WARN Act Coordinators:

This letter is to provide you with information about position adjustments Wells Fargo plans to make in your community. We regularly review and adjust our staffing levels to match the needs of our business. Pursuant to the Federal Worker Adjustment and Retraining Notification Act, Wells Fargo is informing you that it has made the decision to exit the Enterprise Complaints and Remediations group within the Chief Operating Office business unit, impacting three hundred and sixteen (316) employees at the addresses below:

10500 NE Walker Rd, Hillsboro, OR 97006 6305 NE Bennett St. Hillsboro, OR 97124

Two hundred and twenty-nine (229) employees received official written notice via displacement packets on August 22nd, 2023. Notified employees will be provided a 60-day notice period, ending on October 20th, 2023. Additionally, eighty-seven (87) employees were verbally pre-noticed of displacement on August 22nd, with official notification expected to occur by end of 1st quarter of 2024.

It is expected that most, if not all the affected employees will accept severance benefits based on years of service, and the opportunity to continue participating in the company's health plans at active rates for a period of time. Wells Fargo provides an opportunity to participate in career transition services for each employee at no cost.

Employee reductions are never easy for either the employees or for Wells Fargo. We will make every effort to minimize the impact and ease the transition for our affected employees. The affected employees do not have bumping rights and are not represented by a union.

Pursuant to the Federal Worker Adjustment and Retraining Notification Act, this letter is to provide notice that Wells Fargo is implementing layoffs within the Enterprise Complaints and Remediations group within the Chief Operations Office business unit. This action is anticipated to be permanent. The two hundred twentynine (229) affected employees notified on August 22nd are located at the addresses below:

The impacted employees received 60 days' notice via displacement packets.
