RE: WARN Act Notification

All:

Rogue Valley Transit District ("RVTD") is poised to experience a complete loss of federal funds. RVTD cannot maintain current service levels without federal funding and it is currently unknown when federal funds for transit will be forthcoming.

This letter will serve as official notice that RVTD intends to implement a permanent layoff of employees at 101 South Front Street Medford OR 97501 on August 30, 2025. This letter is being provided pursuant to the Workers' Adjustment Notification and Retraining Act (WARN), Public Law 100- 379.

The total number of employees to be laid off is eighty-two. Attached you will find a list of job titles and the total number of employees that will be affected in each job classification. Employees were notified of the impending layoff June 23 - 29, 2025. It is expected that this will be a mass layoff and will occur on August 30, 2025.
