Re: Intel Reduction of Staff

Dear Sir or Madam,

This letter is to notify you of upcoming changes at Intel Corporation, located at the addresses below that may trigger the Federal Worker Adjustment Retraining and Notification Act (“WARN”). Intel Corporation (“Intel” or the “Company”) notified your office on July 7, 2025 that 529 employees working at Intel’s Facilities in Oregon starting July 15, 2025. Intel now anticipates that the planned action will affect a combined total of approximately 2,392 employees at or reporting to the Facilities. These actions are expected to be permanent.

The Facilities include:

- 3585 SW 198th Ave., Aloha, OR 97078
- 2501 NE Century Blvd, Hillsboro, OR 97124
- 5200 NE Elam Young Pkwy., Hillsboro, OR 97124
- 2111 NE 25th Ave., Hillsboro, OR 97124

All impacted employees are being or have been notified of separation either (i) at least 60 days before their separations are scheduled to occur; or (ii) approximately four weeks before their separations are scheduled to occur and, in lieu of further notice, are receiving or will receive nine weeks of pay and benefits. The first separations are presently scheduled to occur during a 14-day period commencing on July 15, 2025.

No affected employees will have the right to bump or displace other employees, and there is no union representing the affected employees. A list of job titles and the number of employees currently holding affected positions, as well as any other information required pursuant to 20 C.F.R. §639.7(f), will be maintained on site and readily accessible to your office.

This announcement and the above timetable are based on the best information currently available. To the extent this action constitutes a covered event under the WARN Act, or any similar state statute, this letter is intended to fulfill any requirements imposed under those laws. By providing this information, however, the Company does not concede that any such laws apply or that notice is otherwise required.
