This letter will serve as official notice, pursuant to the Worker Adjustment and Retraining Notification (WARN) Act and applicable state laws, that Vibra Specialty Hospital of Portland will be closing the hospital and conducting a permanent reduction in force due to ongoing financial challenges that have made it unsustainable to continue operations at 10300 NE Hancock Street, Portland, OR 97220 on or about February 1, 2026.

The total number of employees to be laid off is 310. Attached you will find a list of job titles and the total number of employees that will be affected in each job classification. All impacted employees are being, or have been, directly notified of separation at least 60 days before their separations are scheduled to occur. In compliance with federal and state requirements, this notification is issued to ensure that the appropriate State Rapid Response Dislocated Worker Unit and chief elected local government officials are properly informed in advance of the planned reduction in force. No affected employees will have the right to bump or displace other employees, and there is no union representing any of the affected employees.
