Subject: WARN Act Notice

Dear Ms. Roberts:

Please consider this letter notice in accordance with the Worker Adjustment and Retraining Notification Act ("WARN Act").

Blount International, Inc. ("Blount") is ceasing chain production operations at its facility located at 3901 SE Naef Road, Milwaukie, Oregon 97267 and consolidating much of those operations into Blount's facility located at 4909 SE International Way, Portland, Oregon 97222. As a result of this consolidation, Blount will be discharging or transferring the vast majority of the employees at the Milwaukie facility. We will also be discharging employees at the Portland facility, but overall, the number of employees at the Portland facility will increase in order to perform the chain production operations being transferred to that facility. Blount expects this action will be permanent.

Blount expects that the employees subject to termination of employment will be discharged between October 8 and October 22, 2013. Enclosed as Exhibit A is a list of job titles of the affected positions and the number of persons employed under each job title. The affected employees do not have bumping rights. None of them are represented by a union.
