Subject: Umatilla Chemical Agent Disposal Facility Closure – Notification of WARN

To Whom It May Concern:

This letter constitutes your official notification, for purposes of the Worker Adjustment and Retraining Notification Act (WARN Act), that the Washington Demilitarization Company, LLC (WDC), Federal Services, URS, project at the Umatilla Chemical Agent Disposal Facility (UMCDF), 78068 Ordnance Road, Hermiston, Oregon 97838, has completed its Operations mission and has begun closure activity. The project will ultimately be permanently closed. In accordance with our Closure Plan, all employees will be permanently released from the project as their duties come to an end.

Closure commenced on October 26, 2011. You previously received notice of the Demolition Complete Phase 4 closure milestone effective July 17, 2014. This release is associated with the Closure Complete (Associated Regulatory Action Complete) closure milestone and will affect approximately 26 employees. The reduction-in-force will occur on October 9, 2014, or within a two-week period. Enclosed is a document that contains the list of positions and the number of employees affected by this permanent layoff. This reduction will also affect employees represented by the Demil Trades Council and the Laborers International Union, Local # 121. We have attached a list of the Union representatives for those employees. The UMCDF closure campaign will consist of a series of reduction-in-force actions associated with the significant closure milestones. You will receive multiple WARN notices reflecting the progress of the reduction of our workforce.

Washington Demilitarization Company, LLC (UMCDF) has no seniority system that provides bumping rights to other positions or contracts. The reduction-in-force for employees represented by a Collective Bargaining Agreement is conducted under the terms of these Labor Agreements between Washington Demilitarization Company and the Demil Trades Council and/or the Laborers International Union, Local # 121.
