Dear Mayor Willey:

After serious consideration, Bank of America has decided to consolidate and reduce staff in the Consumer Lending unit at 21000 NW Evergreen PKWY Hillsboro, OR 97124. These layoffs are expected to be permanent.

Notification began on July 6, 2016, and the effective date of separation is expected to occur in phases between September 04, 2016 to September 30, 2016. As a result of this decision, approximately 102 employees have been impacted. Eligible employees are offered career transition resources as well as severance pay and benefits. No bumping rights exist. Employees at this site are not represented by a Union.
