Dear Mr. Asher:

Pursuant to the notification requirements of the Worker Adjustment and Retraining Notification Act of 1988 ("WARN"), Microsoft hereby provides notice of a layoff and plant closure. This notice follows and is related to Microsoft's notices on July 10, 2017, November 6, 2017, and December 5, 2017, in which we notified you of the elimination of 61, 50 and 6 positions, respectively.

Microsoft has decided to reorganize and restructure operations resulting in the elimination of an additional 7 positions located at Microsoft's Wilsonville, OR facility located at 26755 SW 95th Ave., Wilsonville, OR 97070. All 7 additional positions are being permanently eliminated as of March 23, 2018. Microsoft has provided all 7 affected employees with Worker Adjustment and Retraining Notifications. All affected employees will be terminated on March 23, 2018. A list of all affected job titles and the number of individuals affected in each job title is enclosed as part of Attachment A.

Microsoft's decision to eliminate 7 positions located at the above referenced facility is final and is expected to be permanent. These eliminations will result in the closure of the facility. The affected employees are not entitled to an opportunity to "bump" or trade places with individuals who are not affected by the decision.

On January 22, 2018, Microsoft sent notice via hand delivery (or overnight courier and email if not present in person) to all affected employees. Notice was also sent to the City of Wilsonville and Clackamas County for affected worksites on January 22, 2018.
