RE: Notice of Plant Closing

Dear Mr. John Asher:

Georgia-Pacific Wood Products LLC (the "Company") will be permanently closing its facility at 63779 Mullen Street, Coos Bay, OR 97420 (the "Coos Bay facility"). The closure has been prompted by evaluations that concluded that operating the facility was no longer competitive due to overall market conditions and unreliable — and often disabled — rail service. This notice is being provided to you pursuant to the Worker Adjustment and Retraining Notification Act, 29 U.S.C. § 2101 ("WARN").

This action is expected to result in the permanent elimination of employment for 111 employees -13 salaried and 98 hourly positions. The Company expects to begin eliminating positions on or about June 10, 2019 and will continue in phases until complete closure.

Georgia-Pacific will work closely with affected employees and the designated collective bargaining representative of the facility's hourly employees to minimize the impact of this business decision. The designated collective bargaining representative of the facility's hourly employees is the International Association of Machinists and Aerospace Workers, AFL-CIO, Woodworkers Local Lodge W-261 (the "W261-IAM" or the "Union"). The representative of the Union is Donald E. Turner, Jr., Local Lodge W-261 President (located at 3427 Ash Street, North Bend, OR 97459). Union employees currently have bumping rights under the terms of their labor agreement; salaried employees do not have bumping rights.

Attached is a list of job titles and the number of employees affected within in each job title.

The Company will ensure that employees will be paid all earned wages and agreed upon benefits at the time of their discharge.
