This **amended** notice is being provided by United Natural Foods, Inc./SUPERVALU INC. ("UNFI") pursuant to the Worker Adjustment and Retraining Notification Act of 1988 (WARN), which requires employers to give 60 days' advance notice to certain government units or officials of a pending facility shutdown or mass reduction in the workforce. This notice provides the revised, expected closure schedule as identified below to amend the previous notice dated January 9, 2020.

UNFI will permanently close its operations at the UNFI Distribution Center located at 6433 SE Lake Rd., Milwaukie, Oregon 97222. Only some drivers and regional operations and corporate administrative employees in the following departments: information technology, marketing, meat, merchandizing, produce, professional services, and sales, will remain employed, and they will continue to work remotely or from office space at or near the facility. We expect the layoffs at UNFI will be permanent. As previously reported, we anticipate that the facility's closing will occur in several stages, with the first set of employees impacted by the closing having already been separated on March 14, 2020. The final set of employees impacted by the closure previously scheduled for separation during the 14-day period commencing July 4, 2020, is moved to the 14-day period commencing August 15, 2020, due to business need for extended warehouse operations resulting from the COVID-19 pandemic. Bumping rights that may exist for affected workers will be honored. There are approximately 280 employees who will be affected by this facility closing.

A portion of the affected employees at this facility are represented by unions. Amended notices have been provided to the local unions and their chief elected officers and/or bargaining agents. Their contact information is as follows:
