RE: WARN Act Notification

Mr. Asher:

Due to the announcement by Oregon Governor Kate Brown on November 13, 2020 that effective November 18, 2020 for at least two weeks (and anticipating up to four weeks in certain counties) in Oregon, restaurants and bars are ordered closed for dining in. This has affected the operations of Jasper's Food Management, Inc., a non-union company.

Because of this notification, we have had to temporarily lay-off a total of 146 employees in Oregon at the following locations. The return to work date is currently unknown, but best estimate is between December 2nd and December 17th, 2020 for Oregon employees. Below are the affected location addresses and the number of employees per location:
