RE: WARN Act Notification

Mr. Asher:

Due to the announcement by Oregon Governor Kate Brown on March 16, 2020 that effective March 17, 2020 for at least four weeks in Oregon, restaurants and bars are ordered closed for dining in. This has affected the operations of Jasper's Food Management, Inc., a non-union company.

Because of this notification, we have had to temporarily lay-off a total of 172 employees in Oregon at the following locations. The return to work date is currently unknown, but best estimate is April 15, 2020 for Oregon employees. Below are the affected location addresses and the number of employees per location:
