NOTICE TO AFFECTED EMPLOYEES

RE: Notification of Mass Layoff Pursuant to the Worker Adjustment and Retraining Notification Act of 1988

Dear Mr. Asher:

As you know, due to the recent international medical crisis, the Governor of Oregon has ordered the Multnomah Athletic Club ("MAC") to close its operations to members. To minimize the financial impact of this decision, MAC has placed many of its employees on paid leave through April 30, 2020. Nonetheless, because of current developments that now make it clear that this crisis will not be resolved in the near future, MAC is forced to reduce its workforce and lay off 635 employees at its facilities located at 1849 SW Salmon St., Portland, OR 97205. MAC expects to lay off employees starting on May 1, 2020. After the layoffs, MAC will continue to provide some remote member services.

This notice is issued in compliance with the Worker Adjustment and Retraining Notification (WARN) Act. Earlier notice of the layoff was not possible because of the unforeseen business circumstances created by the COVID-19 pandemic and recent developments regarding the spread of the virus. In addition, the COVID-19 virus constitutes a natural disaster that prevented MAC from providing earlier notice of the layoffs.

At this time, MAC is uncertain how long these layoffs will last. While MAC expects them to be temporary, there is a possibility that they could last for six months or more.

The affected employees are unrepresented, and under company policies, there are no "bumping rights" available to affected employees. A list of the job classifications affected by the closing and the number of affected employees in each job classification is attached as Appendix A.
