Pursuant to the Worker Adjustment and Retraining Notification (WARN) Act, Public Law 100- 379, PCC Structural's implemented a permanent layoff of employees at PCC Structural's Inc. at the following locations on or about April 10, 2020:

9200 SE Sunnybrook Blvd, Suite 240, Clackamas, OR 97015
4600 SE Harney Dr, Portland, OR 97206
2690 SE Mailwell Dr., Milwaukie, OR 97222
9800 SE McBrod Ave, Suite 2, Milwaukie, OR 97222

The unforeseeable, significant downturn in business caused by the coronavirus ("COVID-19") pandemic has resulted in a decrease in our customers' production levels and product orders.

As of July 24, 2020, the total number of employees laid off was 94. Attached you will find a list of job titles and the total number of employees that were affected in each job classification. Some employees (below the WARN threshold) were notified of an impending layoff on April 13, 2020, and the layoff occurred April 15, 2020. Additional layoffs based on the same unforeseen business circumstances began on May 4, 2020 and continued through July 24, 2020. Due to unforeseen business circumstances, PCC Structural's was unable to provide earlier notice.

There is no union representation at this facility. Company provisions for transfer, bumping or reassignment do exist and may slightly impact the final layoff count.
