This letter will serve as official notice that W.R. Grace and Co. intends to implement a permanent layoff of employees at 1290 Industrial Way SW on or about December 31, 2023. This letter is being provided pursuant to the Workers' Adjustment Notification and Retraining Act (WARN), Public Law 100- 379.

The total number of employees to be laid off is 95. Attached you will find a list of job titles and the total number of employees that will be affected in each job classification. Employees were notified of the impending layoff on June 13, 2023. It is expected that this will be a permanent closure and will occur on [date].

Additional layoffs may occur and are expected to begin on March 31, 2024 and continue throughout June 30, 2024.
