I am writing on behalf of Osso VR, Inc. (the "Company") to give you notice that there will be a mass layoff at the Company's corporate headquarters located at 548 Market St., PMB 78848, San Francisco, CA 94104-5401 on March 28, 2024. This mass layoff is expected to be permanent.
