Please be advised that, on or around April 22, 2024, Plexus Corp. will begin laying off a number of its employees at its Portland Manufacturing Site located at:

19018 NE Portal Way
Portland, Oregon 97230.

The separations of the affected employees are expected to occur in 2 waves. Consistent with these plans, the last day of employment for the affected employees is anticipated to be one of the following dates:

- June 28th, 2024 or within 14 days thereafter -or-
- September 27th, 2024 or within 14 days thereafter

The total number of employees to be laid off is 75. Attached you will find a list of job titles and the total number of employees that will be affected in each job classification.

Employees will be notified of the impending layoff on April 22, 2024. It is expected that this will be a permanent closure and will occur on June 28th, 2024.

There is not union representation at this facility. Company provisions for transfer, bumping or reassignment do not exist.
