Dear Sir:

This letter is being provided pursuant to the Workers' Adjustment Notification and Retraining Act (WARN Act), Public Law 100- 379. This letter will serve as official notice that Multnomah University intends to implement a permanent layoff of employees at 8435 NE Glisan St, Portland, OR 97220 on or about June 30, 2024, in conjunction with the closing of Multnomah University. Multnomah University does not believe that this closure triggers WARN notices, and Jessup University will continue operations at the site and intends to hire former employees of Multnomah University. However, out of an abundance of caution, Multnomah University is issuing WARN notices, and is doing so as early as practicable in light of unforeseen circumstances. Jessup University will make all hiring decisions. We appreciate the outstanding work our employees have done for our students and we thank them for their years of service.

The total number of employees to be laid off is 81 full-time employees and 7 part-time employees. Attached you will find a list of job titles and the total number of employees that will be affected in each job classification. Employees will be notified of the impending layoff on May 7, 2024. It is expected that this will be a mass layoff of all of Multnomah University's employees, which will occur on June 30, 2024. No further layoffs are scheduled.

There is no union representation at this facility. Company provisions for transfer, bumping, or reassignment do not exist.
