Re. Layoff - WARN Notice

On May 29, 2025, Management & Training Corporation ("MTC"), contract operator of the **Tongue Point Job Corps Center**, **37573 US-30**, **Astoria**, **OR 97103** (the "Center"), was notified by the U.S. Department of Labor ("DOL") that its contract for the operation of the Center is being terminated for convenience effective June 30, 2025. No new operator is being contracted to operate the Center.

As a result of this unanticipated government-initiated contract termination, MTC is required to close the Center and terminate all Center staff. This unforeseen business circumstance prevents MTC from being able to provide a full 60 days' notice of termination to employees. This notice was prepared as expeditiously as possible.

All Center staff employment will end by June 30, 2025, though portions of staff will transition out each week. Below is the current anticipated schedule:

- June 6 Substitute staff and student workers, excluding security and residential;
- June 13 Residential substitutes;
- June 20 Most departments except those listed on later dates (safety officer, drivers, mental health consultant, secretaries, buyers, and TEAP are included in this round);

- June 27 Health & Wellness (Manager, nurses, secretary), Center Director and Finance & Administration secretaries, Records Department; and
- June 30 Center Director Position and the following departments: Maintenance, Security (except those listed above), Finance & Administration, Accounting, Property.

MTC's determination to lay off its staff is expected to be a permanent action; employees do not have bumping rights. Attached please find the job titles affected and the number of employees in each category.
