**Re: WARN NOTICE - PLANT CLOSING**

This Notice is being provided to inform you that Owens Corning (the "Company"), will be closing the facility located at 1155 N Main Street, Prineville, OR 97754, (the "Facility") and will begin laying off all employees at the Facility on August 25, 2025. After August 25, 2025, some employees will remain with Company to assist with winding down the Facility. Those employees who remain to assist with winding down the Facility will be laid off during a period in September, with the final employees being separated in November. The anticipated schedule for the September separation dates is between September 19, 2025 and September 26, 2025. The anticipated date for the final group of employees to be laid off is November 30, 2025. As of November 30, 2025, all employees at the Facility will be laid off. The closing is expected to be permanent. Given the Facility is closing, bumping rights do not exist.

Attached to this Notice are the job titles of the positions to be affected and the number of affected employees in each job classification. There is no Union associated with this Facility.

This Notice is based upon the best information that the Company has available to it at this time. If there are any changes in the Company's plans, or in the timing of the layoffs, you will be notified as soon as possible.

The above actions may constitute a covered event for the purposes of the Federal Worker Adjustment and Retraining Notification ("WARN") Act, and this letter is intended to fulfill the Company's obligations under that Act.
