This letter is provided to inform you of position adjustments Wells Fargo plans to make in your community. Pursuant to the Federal Worker Adjustment and Retraining Notification Act (WARN), this letter is to provide advance notice of Wells Fargo's decision to exit support operations at the following location:

10500 NE Walker Road Hillsboro, OR 97006

Pursuant to the Federal Worker Adjustment and Retraining Notification (WARN) Act, this letter serves as formal notice that displacement notifications were issued to two-hundred and sixty-three (263) affected employees on October 28, 2025, via displacement packets. These employees will be provided a 60-day notice period, with an official separation date of December 26, 2025. This action is anticipated to be permanent. The affected employees do not have bumping rights and are not represented by a union.

These business decisions are never easy. We are very thoughtful and deliberate in our approach, understanding the impact these decisions have on individuals at the company. Wells Fargo is committed to supporting our displaced employees and provides severance, career assistance, and other services to assist them. We will make every effort to minimize the impact and ease the transition for our affected employees.

It is expected that the affected employees will accept severance benefits based on years of service and the opportunity to continue participating in the company's health plans at active rates for a period of time. Wells Fargo provides career transition services for each employee at no cost.
